CONCERNING

STIPULATION ON THE TYPE OF STRATEGIC CONTAGIOUS ANIMAL'S DISEASES BY THE BLESSING OF GOD

ALMIGHTY

MINISTER OF AGRICULTURE

- Considering:

 a. That in the context of minimizing that in order to minimize economic losses, human health, the environment, community unrest, high animal mortality and / or potential entry and spread of animal diseases, it is necessary to control and eradicate contagious animal's diseases.
 - b. That based on the considerations as referred to in letter a and at the same time as implementing the provisions of Article 43 paragraph (1) of Law Number 18 Year 2009 concerning Animal Husbandry and Health, it is necessary to stipulate the type of strategic contagious animal's diseases, by Decree of the Minister of Agriculture.

DECIDES

To stipulate :

FIRST : Stipulate types of Strategic contagious animal's

diseases (SCAD) which are already existing in

Indonesia and do not yet existing in Indonesia.

SECOND : Types of SCAD the diseases of which

are already existing in Indonesia as referred to

in DICTUM FIRST as follows:

- a. Anthrax;
- b. Rabies;
- c. Salmonellosis;
- d. Brucellosis(Brucella Abortus);
- e. Highly pathogenic avian influenza and Low pathogenic avian influenza;
- f. Porcine reproductive and respiratory
 syndrome;
- g. Helminthiasis;
- h. Haemorrhagic septicaemia/ septicaemia
 Epizootica;
- i. Nipah virus encephalitis;
- j. Infectious bovine rhinotracheitis;
- k. Bovine tuberculosis;
- 1. Leptospirosis;
- m. Brucellosis (Brucella Suis);
- n. Jembrana Disease;
- o. Surra;
- p. Paratuberculosis;
- q. Toxoplasmosis;
- r. Classical Swine Fever (CSF);

- s. Swine Influenza Novel (H1N1);
- t. Campylobacteriosis;
- u. Cysticercosis; and
- v. Q fever.

THIRD

- : Types of SCAD the diseases of which are not existing yet in Indonesia as referred to in DICTUM FIRST potentially to emerge and cause an economic loss, human's health, environment and public's restlessness are as follows:
 - a. Foot and Mouth Disease;
 - b. Bovine spongiform encephalopathy (BSE); and
 - c. Rift Valley Fever (RVF)

FOURTH

: Types of PHMS as referred to in dictum SECOND become the priority in their control and overcoming at affected area with the national priority.

FIFTH

: For types of SCAD not existing yet in Indonesia as referred to in dictum THIRD it is taken anticipation through prevention and surveillance act as well as veterinary emergency preparedness and contingency plan by the directorate general of livestock and Animal Health Services and Indonesian Agricultural Quarantine Agency according to their respective authority.

SIXTH

: Such types of SCAD as referred to in dictum

SECOND and dictum THIRD will be reviewed and

re-evaluated periodically once in every 3 (three)

years or at any time when a disease occurs.

SEVENTH

: The control and eradication of the type of SCAD as referred to in the SECOND and THIRD dictum is carried out by the Government, the provincial government, and the district / city regional government according to their respective authority.

EIGHTH

: Types of SCAD in Indonesia that have not been determined under this Ministerial Decree, are determined by the Director General of Animal Husbandry and Health, taking into account the priority of animal diseases in each region.

NINTH

: The cost required in the context of control and eradiate animal diseases as referred to in the SEVENT dictum are funded by the APBN, provincial APBD, regency / city APBD, and other legal sources in accordance with the laws and regulations.

TENTH

: This Ministerial Decree shall take effect as from the date of stipulation.
